The Direct Vision Standard (DVS)



What is the Direct Vision Standard?

The Direct Vision Standard (DVS) and HGV safety permits are part of the Mayor of London's Vision Zero plan to eliminate all deaths and serious injuries on London's transport network by 2041.

The scheme was created to improve the safety of all road users, including pedestrians, cyclists and motorcyclists. The DVS requires all lorries over 12 tonnes gross vehicle weight to be granted a safety permit to enter or operate in Greater London. The new regulation introduces a star rating system based on what is directly visible to the driver from the cab. Vehicles will have to have at least a 'one star' rating to become DVS compliant and obtain a HGV safety permit.

When will The Direct Vision Standard be enforced?


Originally planned for October 2020, enforcement will now be introduced from 1st March 2021. The extension date has been granted to give the freight industry more time to meet the new standards as they face new challenges and demands from the coronavirus pandemic.

Enforcement and penalties

Once enforcement starts, if you drive an HGV within Greater London without a valid permit you may receive a penalty charge notice (PCN) of up to £550 (reduced to £275 if paid within 14 days).

Safe System

The Safe System is a series of vehicle safety measures (fitted after point of manufacture) which are designed to reduce the risks that HGVs present to people walking and cycling. The added safety measures will give the driver greater visibility which help improve road safety within London.



Overview of Safe System requirements for zero star-rated vehicles:

- 1. Class V mirror must be fitted to the nearside of the vehicle.
- 2. Class V1 mirror must be fitted to the front of the vehicle.
- 3. Side under-run protection must be fitted to both sides of the vehicle (except where this is impractical or proves to be impossible).
- 4. External, pictorial, stickers and markings must be displayed on vehicles to warn vulnerable road users of the hazards around the vehicle.
- 5. A sensor system that alerts the driver to the presence of a vulnerable road user must be fitted to the nearside of the vehicle.
- 6. Audible vehicle manoeuvring warning must be fitted to warn vulnerable road users when a vehicle is turning left.
- 7. A fully operational camera monitoring system must be fitted to the nearside of the vehicle.


